ADMISSION & DISCIPLINE POLICY

- **1. Students Guide:** Finally selected course participants are to abide the following Rules and Regulations:
 - a) Upon admission, each student will receive a non-transferable School ID card, containing necessary particulars and a photograph. Students must carry their ID cards daily. In case of loss, a duplicate card will be issued with a fine of Rs. 2000.
 - b) Admission, once finalized, is non-refundable. The managing committee may, under exceptional circumstances, refund fees for deserving cases.
 - c) To attain the "Successful Completion Certificate," a student's attendance must be 80%. A "Participation Certificate" will be issued for 50% attendance. Certificates can be withheld until dues are cleared.
 - d) Students are responsible for damages to school/hostel property.
 - e) Admission is conditional on students maintaining attendance, satisfactory performance, and achieving prescribed standards. Absences, except on medical grounds, are unacceptable. Medical leave should not exceed one week.
 - f) Students and hostel residents are expected to exhibit behavior in line with Pakistani customs.
 - g) Admission may be terminated for conduct breaches, including discipline, misuse of social media, drug or addiction. No fee refund upon expulsion.
 - h) Incidental costs will be charged to students' accounts.
 - i) The school provides first aid; routine health expenses are borne by parents/guardians.
 - j) Cell phones are not allowed in class; ringing or texting may result in confiscation.
 - k) Students cannot leave class during lectures, and leaving the school premises without permission is not allowed.
 - I) Valuables are discouraged; the school is not responsible for missing items.

2. Parents' Guide:

- a) Parents/guardians may seek appointments with the Director for discussions on their daughters'/wards'/wives' progress or issues.
- b) Coordinated visits with the school should occur before the session starts for a tour, providing insight into school activities/facilities.
- c) Students will undertake educational/field trips as part of their curriculum.
